Section II - PROJECT DESCRIPTION

Preservation Parks is seeking qualifications for survey, design, engineering, bidding, and construction services for a 10′ wide, 1,500′ long multi-use asphalt rail to trail northeast of Sunbury, Ohio. Included in the project is a 220′ railroad bridge that will be converted to pedestrian and bicycle use. Please note that this project is being partially funded by ODNR's Clean Ohio Trail Fund grant and State Capital Funding.

Project Location: Ohio to Erie Trail

Section III – SCOPE OF WORK

- A. Attend an on-site kickoff meeting and up to three design review meetings with PPDC staff. Respond to staff review comments.
- B. Topographic survey suitable for the design of the trail and bridge work.
- C. Review existing bridge visual inspection report completed in 2018. Incorporate bridge conclusions into the final engineering plans. This includes new decking and railing system, bridge abutment scour stabilization, bridge seats and bearing repair, and address abutment approach areas. Sandblasting and cleaning the entire bridge is not included in the project.
- D. Review existing USACE Nationwide Permit for work in stream. Incorporate requirements into the final engineering plans. Coordinate with USACE as needed.
- E. Final Engineering plans for a 10' wide asphalt trail and pedestrian bridge.
- F. A widened area/overlook on the bridge (+- 3' on each side) shall be included to accommodate space for visitors to pause on the trail.

- G. Deliver PDF of construction plans, details, specifications and Engineer's cost estimate to PPDC.
- H. Provide Bidding and contract award services (advertisement, plan distribution, pre-bid meeting, issuing addendum, execution of contract, etc)
- I. Provide construction administration and limited site inspection services (review of shop drawings, answer RFIs, site visits during construction, punch list, close out documents, etc)


