- 6. M. Simpson updated the board on bids received for the Emily Traphagen Boardwalk Construction project. Three bids were received, and Axis Civil Construction submitted the lowest and best bid in the amount of \$131,600. G. Marzluf moved to award the Emily Traphagen Boardwalk Construction project to Axis Civil Construction in the amount of \$131,600 with a contingency up to \$135,000. J.
